**PART I. GENERAL EXPECTATIONS**

The Lake Erie International High School agrees to implement the following statutory requirements:

4. The Lake Erie International High School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Lake Erie International High School will provide support during scheduled Open Houses and during Parent/Teacher conferences. Materials and equipment include presentations and questions and answer forums that will be conducted to address the above stated topics. Information provided to parents will include explanation of academic assessments given through-out the school year. Parents will also be recommended to participate in the Parental Leadership Council Network provided by State Support Team 3 and the Educational Service Center of Cuyahoga County.

B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- A. *Foster parental involvement by providing volunteering opportunities for parents.*
- B. *Seek parent input to establish training needs.*
- C. *Collaborate with various agencies and resources in the community that can assist parents with students' success in school.*
- D. *Conduct family training/classes to help parents become full partners in the education of their child.*

C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

  - B. *By offering teachers, pupil services personnel, principals and other staff professional development opportunities relative to outreach, building relationships and coordinating with parents.*
- D. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

Lake Erie International High School will provide this information via a variety of platforms in order to insure parents remain informed regarding meetings, programs and other activities. These platforms will include Bright Arrow Phone Notification, Constant Contact Newsletter, which also offers information for Spanish speaking parents and students, and the Lake Erie International High School website.
